| <ol style="list-style-type: none"> <li>1. You may install <b>DRPRO-NL</b> (Network Licence) on every workstation in the office within the same Local Area Network.</li> <li>2. Everyone can have access to <b>DRPRO-NL</b> from their own workstations simultaneously, up to the number of Network Licences on subscription for the year. You decide where to install and who should have access to it.</li> <li>3. This is an <b>Annual Subscription</b> and entitles you to all new updates (major or minor) during the subscription period. See also Note 7.</li> <li>4. The pricing is simple: One single price per Network Licence per year. If additional Network Licences need to be added half-way through the year, they will be priced pro-rata until the next renewal date. This way the renewal date is kept the same for all Network Licences.</li> <li>5. After one year, the <b>Annual Subscription</b> becomes renewable. A reminder will be emailed 2 months before expiry and again 1 month later.</li> </ol> | <ol style="list-style-type: none"> <li>6. However, your existing data will always be accessible as <b>View and Print</b> only. You will NOT be locked out of your existing data.</li> <li>8. If not renewed for a while, you may restart a new Annual Subscription at any future time at the prevailing price and also upgrade to the latest version. (No need to pay arrears Annual Subscriptions to get up-to-date). All existing data will be upgraded.</li> <li>9. The 'Network Licences' are allocated per Data Set. If you have multiple DRPRO Data Sets within the same Network, each Data Set is treated independently with its own number of 'Network Licences'. These licences can be transferred from one Data Set to another at any stage and at no extra cost.</li> <li>10. Please note that the DRPRO Network Licences (NL) are Floating / Roaming Licences.
